**BOARD OF TECHNICAL EDUCATION, RAJASTHAN, JODHPUR**  
**RULES AND REGULATION (Revaluation)**  
**FOR DIPLOMA COURSES IN ENGINEERING AND NON ENGINEERING**  
**DIPLOMA ANNUAL SCHEME**

1. A Student who wishes to apply for revaluation of answer-book(s) must submit online application on the portal wide his/her SSOID before expiry of 15 days excluding the date of the declaration of his examination result. Application not submitted online by the due date shall be rejected. Incomplete application forms will be rejected.

Seperate Application should be submitted for each year in which he/she is appearing as regular and/or Ex-student in an examination.

2. The fee for revaluation will be Rs. 400 /. per paper.

3 The revaluation fee will not be refunded in any case.

4. Revaluation of answer books shall not be permitted in more than 50% of the theory papers in which a student appeared for each year in which he/she is appearing as regular and/or Ex-student in an examinaion.

5. Notwithstanding the aforesaid provisions, revaluation of answer-books shall not be permitted in respect of practical examination/Interal Assessment/class tests/seminar/Summer Internship, and viva-voce.

6. The marks awarded by the re-evaluator will be the final marks of the student whether the marks awarded by the revelator is more or less than marks awarded by the main examiner.

7. The answer-book(s) shall not be subject to any inspection or production before any external or internal authority except at the instance of Chairman.

8. A student who is declared eligible for taking examination of back paper(s) as a result of revaluation shall be permitted to appear at the next main examination related to his/her back papers or if the same is already over, at the time of next main examination related to his/her back papers. Such a student will also be eligible to appear at the next higher examination as an ex-student, if such facility exists for the examination concerned.

9. A student desirous to apply for re-evaluation may treat his result as "No Change" for purposes of submission of application forms for appearing at the ensuing examination within due date.

10. Students should presume their result as unchanged for all purposes until declaration of the result of revaluation of their scripts.

11. These Rules will be applicable for the Special exam 2021-22 and onwards.

12. All court cases shall be subject to the jurisdiction of the Board at Jodhpur not at any other place.
